1 CALL TO ORDER

1.1 Mayor St. Jacques called the meeting to order at 7:30 pm

2 ADOPTION OF MINUTES

2.1 September 20, 2016 Harbour Authority Minutes

HA-38 It was moved by Councillor Oliwa and seconded by Councillor McEwen

THAT the Harbour Authority approve the September 20, 2016 minutes as presented.

CARRIED.

3 UNFINISHED BUSINESS

3.1 Mayor St. Jacques requested confirmation if Mr. Atkinson was provided with a report in response to his questions, to which Ms. O'Connor responded that he had received it.

4 PUBLIC INPUT AND PRESENTATIONS

- 4.1 Public Input
 - D. Kimoto expressed his concern that the Department of Fisheries and Oceans (DFO) placed the breakwaters in a way that has cut down on moorage capacity in the area, and that the breakwaters are quite wide
 - Council responded that they also have questions for DFO, such as the appearance of the rusty pilings, and will bring the question of the configuration forward at their next general meeting with them in early 2017

5 CORRESPONDENCE

5.1 2017 HAABC Seminar and AGM on January 17-20 in Port Alberni Harbour Authority Association of British Columbia

It was moved by Councillor McEwen and seconded by Councillor Noel

THAT the Harbour Authority approve sending Councillor Oliwa and the Chair of the Harbour Advisory Commission to the HAABC Seminar and AGM on January 17-20, 2017 in Port Alberni.

CARRIED.

6 REPORTS FROM COUNCIL OR STAFF

6.1 Harbour Management Report - General Update Kevin Cortes, Harbour Contractor

HA-40

It was moved by Councillor McEwen and seconded by Councillor Mole THAT the Harbour Authority receive Mr. Cortes' general update report for information.

CARRIED.

6.2 DRAFT Minutes - Harbour Advisory Commission - November 11, 2016

HA-41

It was moved by Councillor Oliwa and seconded by Councillor McEwen THAT the Harbour Authority receive the November 9, 2016 Harbour Advisory Commission minutes for information.

CARRIED.

Public Walkway Extension in Inner Boat Basin

 Mayor St. Jacques noted that the District planner is aware of this project but that it is not yet a budget item; Council discussed that the District currently does not have permission to install a walkway around the entire inner basin at this time

HA-42

It was moved by Councillor Mole and seconded by Councillor Oliwa

THAT the Harbour Authority forward the idea of a public walkway extension in the Inner Boat Basin to Resort Municipality Initiative budget discussions.

CARRIED.

New Fingers and Cost Recovery for Maintenance

 Mayor St. Jacques noted that there is a budget and plan to install five new fingers on the Canadian Princess side of the harbour, and noted that cost recovery would happen through moorage and costs of each unit

Coast Guard Auxiliary Boat Shed

- Mayor St. Jacques noted that it is up to the Coast Guard to provide their own maintenance to their infrastructure, but it is understood that the Coast Guard currently do not have the funds to do this work; it was suggested that perhaps the Harbour Advisory Commission could help the Coast Guard with fundraising
- Councillor McEwen noted that the Ucluelet Co-op might have a contest or grant that can be applied to in order to receive 800 gallons of paint at no charge

 Councillor Noel suggested a surcharge to the Small Craft Harbour user group in order to ensure monies are available to maintain water-related infrastructure; it was emphasized that no money collected through the surcharge should go to the contractor, only to the Coast Guard Auxiliary; the surcharge would be a permanent source of revenue for the Coast Guard volunteers

HA-43

It was moved by Councillor Noel and seconded by Councillor Mole

THAT the Harbour Authority direct District staff to devise a surcharge fee structure for the Inner Basin user group that would direct one hundred percent of collected fees to supporting the local Coast Guard auxiliary with maintenance and upkeep of their infrastructure, including their boat shed.

CARRIED.

Retention of 52 Steps and associated Foreshores

- Mayor St. Jacques noted that DFO intends to decommission 52 Steps, and shift this infrastructure to the Inner Basin; suggested that the Harbour Advisory Commission provide the Harbour Authority with the reason for this request as a means to facilitate the discussion with DFO
- Commissioner Kimoto clarified that the concern was in losing moorage space once 52 Steps is decommissioned, as new breakwater does not look to accommodate as many boats in the way DFO configured it; inquired if District could acquire water lot easement near the Imperial Oil property
- Councillor Noel noted that there is concern with Council as well, as the configuration paired with neighbouring foreshore lease does seem to be restricting how many boats can be moored
- Mayor St. Jacques stated that this topic could be added to Council's upcoming discussion with DFO
- Councillor Mole mentioned that better communication should be added to that agenda as well, with the example of how the District had no notice of the breakwaters being installed

April Thefts on Boats & Attendance of Harbour Contractor

- Mayor St. Jacques noted that it is not in the Harbour Manager's contract that he must attend Harbour Advisory Commission meetings, even though the Harbour Authority would also find it helpful to have him at their meetings; suggested that the District look at this when his contract comes due for renewal
- Commissioner Kimoto expressed what was stolen from the three boats, that the thief was caught on video but had a mask on; noted also there are no video cameras facing the parking lot; noted also that Port Alberni uses a gate at their facility
- Councillor Noel provided that people enjoy walking the docks, but that
 the District would need to take action if thefts become a problem;
 inquired if the District has video surveillance, to which Ms. O'Connor
 responded that the District has at least 3 cameras with improvements
 due to come via better quality system

- Ms. O'Connor also provided that Council can add another camera to the budget for the parking lot, and that staff can speak to the Harbour Manager regarding placement and where additional surveillance might be beneficial
- Mayor St. Jacques requested that the District get some feedback from the RCMP on how effective they believe surveillance cameras to be
- Councillor Mole suggested signage in the boat basin indicating that the area is under video surveillance
- Councillor Noel wished to confirm that the video feeds are visible by passerby of the harbour office, to which Ms. O'Connor confirmed they were

Amend Harbour Plan to Include Fish Processors

- Mayor St. Jacques requested clarification on the intention behind asking for fish processors to be included in the 2012 Harbour Plan
- Commissioner Kimoto replied that the request was made for future planning purposes
- Mayor St. Jacques agreed that District staff could add the three businesses – Ucluelet Harbour Seafoods, Neptune Ice, and Ukee Ice – into the plan
- Councillor Noel agreed that the plants are not properly acknowledged in the plan and understands their fear that, if they are in zones nonconforming to their use, they could be at risk, for example Ucluelet Harbour Seafoods is CS-1 zoning; believes it is important to note that Ucluelet has a working harbour

Assessment of Processing Factors

- Mayor St. Jacques requested clarification on the request stating that "a current assessment of processing factors be sought for Ucluelet processors to compete, attract and grow its business and local employment in today's evolving fishery with growing quality demands and fresh markets"
- Commissioner Kimoto noted that the motion was made by Commissioner Alexander
- Mayor St. Jacques responded that the Harbour Authority will wait for further clarification from the Harbour Advisory Commission on this request
- Councillor Oliwa noted that the District had applied for a \$10k grant to update their economic development strategy and that this request might fit into the rewrite nicely

Extension of Water Lease Outside of Inner Harbour

 Mayor St. Jacques noted that Council did discuss this recently, but needed to confirm if the discussion occurred in-camera; it was also noted that Council needs specific reasons for wanting to extend before they can approach DFO

- Planner to Attend next Harbour Advisory Commission Meeting
- Mayor St. Jacques noted that the District would check with Mr. Towgood on his availability and information points he could possibly share
 - Issue of Rusty Pilings
- Mayor St. Jacques noted that Council would definitely be discussing this topic with DFO at their next meeting with them
 - Spill Response Centre
- Mayor St. Jacques noted that the District was currently in conversation
 with Western Canada Marine Response Corporation who are looking to
 locate some of their spill response vessels in Ucluelet; their
 headquarters is in Port Alberni, but if the pipeline is approved, the group
 are very likely to move boats out here

7 NEW BUSINESS

- 7.1 Councillor Oliwa reported on his conversation with Dave Payne regarding the acquisition of the CBC radio antenna, which is reported to be slated for removal by CBC and who have allowed the District of Ucluelet to acquire the equipment on behalf of Ucluelet's local ham radio operators
 - Ms. O'Connor provided that responsibility for the safety of the poles would transfer to the District if the District takes over the equipment; as of today, the poles are the responsibility of CBC
 - Mayor St. Jacques inquired if the poles are currently a safety hazard, and noted that the District should have asked CBC to remove them ten years ago when they stopped using them
 - Councillor Noel commented that in hindsight the District should have made removal of the poles a condition of their request to place new equipment on the District's water tower; as it stands, the poles are likely to be subject to rot if they have not been inspected or maintained

HA-44 It was moved by Councillor Noel and seconded by Councillor Mole

THAT the Harbour Authority direct District staff to send a letter to CBC requesting confirmation of the last inspection date of the radio poles located in Small Craft Harbour, as well as a maintenance plan for the poles.

CARRIED.

- Councillor Mole inquired if there is a current agreement in place with CBC, to which Ms. O'Connor responded that there likely would be though it would be quite old
- Councillor Mole inquired if the local ham radio group already have possession of the equipment, to which Councillor Oliwa replied that the group would like the equipment but in its original location on the poles
- Councillor Oliwa noted the ham operators are well-trained and would not be asking for the poles if they didn't know what they

were doing; stated that Ucluelet is recognized by the Province as having the only ham radio operators in emergency event, and that this group is worthy of that respect; stated that Council needs to hold CBC to the task of maintaining their poles

- Mayor St. Jacques replied that, to ensure the ham operators are safe, the District does need to confirm that the poles are safe
- Councillor Noel stated that he only wanted to know the integrity of the poles and to see documentation to that effect
- Councillor Oliwa noted that in other emergency events, not just earthquake or tsunami, the poles would be valuable


