RECOMMENDATION(S):

THAT Council approve Option A, to explore working with Harbour Authority Association of BC to undertake a review of how the Harbour Authority and District of Ucluelet manage and oversee the harbour.

BACKGROUND:

The Harbour Authority received an offer from Mr. Clark, Harbour Authority Association of BC (HAABC), to undertake an operational review of the harbour and undertake a mentorship program to provide guidance on best practices and possible improved efficiencies in the management of Ucluelet's harbours. Staff have reviewed the offer and believe it is worth exploring. The District of Ucluelet has not undertaken such a review in the past and this may provide some good options and opportunities for improving our harbour operations from a Harbour Authority perspective. We would need to confirm if there are any costs involved.

ANALYSIS OF OPTIONS

This opportunity would provide the Harbour Authority and District staff with much needed knowledge on oversight and operations of the Harbour. A review would be a positive measure to also determine next steps for the Small Craft Harbour and Whiskey Dock. We would also be able to tie in the Harbour Master Plan and be better able to ascertain long-term programs and budgeting for the Harbour. This would be a great opportunity to better understand harbour operations from a Harbour Authority standpoint and to support the Harbour Manager.

RECOMMENDATION(S):

THAT the Ucluelet Harbour Authority deny West Coast Wild Adventures' request to moore a 450 litre dual tank filling station at the Small Craft Harbour.

BACKGROUND:

At the May 2, 2022, Harbour Authority meeting, Staff were directed to provide a report outlining the pros and cons of West Coast Wild Adventures' request to dock a fuel boat next to the existing airplane float dock in the Small Craft Harbour.

Staff contacted the Department of Fisheries and Oceans (DFO) and received information from Transport Canada (TC) to determine if the proposal is permitted under the various regulations that manage and govern the transportation and storage of fuel. Staff also reviewed insurance requirements.

DFO – Small Craft Harbour

DFO cannot authorize or deny a request such as this. The Ucluelet Harbour Authority is solely responsible for determining what activities are allowed within the water lot.

DFO - SCH does not normally support transportation of fuel within our water lots, however, again, that decision would be up to each individual Harbour Authority. If a fuelling system were to be allowed by the Ucluelet Harbour Authority, Ucluelet would need to ensure the operator follows all Transport Canada Guidelines and obtains all necessary approvals and permits required by Transport Canada.

Transport Canada

Provided the requirements of *Transport of Dangerous Goods Regulations* (TDGR) 1.33 are met, there is an exemption in the *Transport of Dangerous Goods Regulations* that allows the transport Class 3 Flammable Liquids in a small means of containment (SMOC) (i.e., less than or equal to 450L) without having to prepare shipping documents, have labels on the tidy tank, or have a UN spec tank. TDR 1.33 reads:

Class 3, Flammable Liquids: General Exemption

1.33 Part 3 (Documentation), Part 4 (Dangerous Goods Safety Marks), Part 5 (Means of Containment), Part 6 (Training), Part 7 (Emergency Response Assistance Plan), Part 9 (Road) and Part 10 (Rail) do not apply to the handling, offering for transport or transporting of dangerous goods

included in Class 3, Flammable Liquids, on a road vehicle, a railway vehicle or a vessel on a domestic voyage if the dangerous goods

- (a) have no subsidiary class;
- (b) are included in Packing Group III and have a flash point greater than 37.8 degrees C; and
- (c) are in one or more small means of containment designed, constructed, filled, closed, secured, and maintained so that under normal conditions of transport, including handling, there will be no accidental release of the dangerous goods that could endanger public safety.

If all the requirements of TDGR 1.33 and the fuel meets all requirements of the TDGR if it is fully regulated, then the 450L tidy tank on an aluminium boat would be compliant with the TDGR.

It is noteworthy that the *Regulation* does not address the longer-term storage and dispensing of fuel from a barge and staff did not identify any additional regulations that would provide oversight of an independent small fuelling station. Additional confirmation will be required from Transport Canada Marine Safety to ensure that they have no issues with the fuelling of a float plane from the tidy tank on the boat.

<u>Insurance Requirements</u>

If the Harbour Authority were to consider approving the request the following insurance requirements would be recommended. As for the third-party insurance, the floatplane operator should carry Aircraft Hull Policy (insuring the floatplanes to their full value) and Aviation General Liability (as they would be required by Transport Canada).

The vessel operator should carry Hull & Machinery (insuring the vessel to its full value) and Protection & Indemnity, which should include pollution liability (as would be required by Transport Canada).

The District of Ucluelet, Harbour Authority, DFO - SCH, Kasslyn Contracting, should be added as an Additional Insured to the Aviation General Liability policy and the Protection & Indemnity policy. The Aviation General Liability policy limit could be as little as \$2M – depending on the size of the client although \$5M would be ideal. Consideration could also be given by the applicant to acquire a Protection & Indemnity policy of \$5M to \$10M. The desire would also be that the West Coast Wild Adventures also provide evidence the pollution liability limit.

ANALYSIS OF OPTIONS

Although permissible, throughout Staff's discussions with DFO and information provided by TC there were several concerns that were raised, and items identified that form the basis of the recommendation.

The primary concern is that there are increased risks of fuel spills with a fuelling station, which are heightened because it would be located in a public facility. A fuel spill would have increased impacts on the marine and aquatic environment and Harbours are already highly impacted from operations and adding increased potential for spillage and contaminants is not desirable.

Small fill stations, such as the one proposed, do not require any training, management, or oversight for the safe dispensing of fuel, therefore pose an increased risk level. Furthermore, there is a private marine filling station within the harbour that is certified and retains all the required safety equipment and training needed to manage a fill station.

DFO - SCH advised the District that they do not normally support the transportation of fuel and fill stations within their water lots primarily due to environmental concerns. They further noted that they are actively deterring the renewal of existing private fill stations due to the increased environmental hazards they pose.

Overall, Staff were unable to identify any benefits to the community at large or the Harbour associated with a fuel boat being located in the Small Craft Harbour.

There is a benefit to the small business to have a fuel boat to support their business, reducing the travel time required to fill their aircraft at the existing fuel station.

If the Harbour Authority were to permit West Coast Wild Adventures to have a fuel boat in place at Small Craft Harbour, Staff recommend several permit conditions be put in place to minimize the potential risks associated with this independent fuelling station. This would require staff time to ensure and monitor that regulations and conditions are being met. Staff would recommend that the permit include:

- 1. Verification that all Transport Canada Regulations are met.
- 2. Confirmation with Transport Canada Marine Safety requirements are met.
- 3. A minimum of \$5 million general third party liability naming the Ucluelet Harbour Authority, District of Ucluelet, Department of Fisheries and Oceans Small Craft Harbour and Kasslyn Contracting with confirmation of pollution liability limit of no less than \$5 million.
- 4. A Marine Response Spill Kit on-site suitable for the volume of fuel being stored and dispensed.
- 5. Submission of a Safety Plan approved by the Ucluelet Harbour Authority and Ucluelet Fire Department.
- 6. A maximum term of 3-years.
