Re: Fibre Optic Infrastructure Line to the West Coast of Vancouver Island

As you are aware, BC Hydro is in the process of replacing a large number of transmission poles that provide power to the west coast of Vancouver Island. Upon completion, Telus will be installing a fiber optic infrastructure line to Ucluelet, Tofino and west coast First Nations communities; providing a higher speed access to internet services. It is our understanding that we will also have access to the fibre line by renting the bandwidth from Telus.

Ucluelet Video Services Ltd. (Ukee Cable) is a family owned and operated company, since 1967. We have provided microwave Internet service for over 12 years to the community of Ucluelet. We have also provided Digital TV since 2001, and HDTV since 2008.

It is of great concern to us that once the fiber line is in place and operational, Telus will be in a position to offer Optik TV; as they have done in other communities, including Port Alberni, Qualicum, and Port Hardy. The District of Ucluelet has a small population of approximately 1,650 and any significant reduction to our subscriber base would be very damaging to our business.

This would essentially mean that we would be competing against tax payers money; creating an unethical and disadvantaged situation to the cable TV companies (including Seaview Communications in Tofino) who have already been providing TV and Internet to the west coast communities without the benefit of government funding.

Telus' commitment to invest 2.8 billion in a fibre optic network to all corners of BC, reportedly comes at no cost to taxpayers. In 2009, \$40.8 million was granted to All Nations Trust Company by the Province of BC and the Government of Canada for the purpose of providing financial stewardship and project management for the Pathways of Technology Project to ensure broadband Connectivity to all 203 First Nations in BC. Any government funding committed was for the purpose of Internet service (not TV).

We have been unable to acquire any information on Telus' future plans in this regard, and would be grateful for any assistance you could offer.
