5.1 Zoning Amendment and Development Variance Permit for 1768 Peninsula Road

Ms. Neweduk presented this report.

In response to Council questions, Staff clarified that the variance related to the parking isle width is supportable as it meets the fire access lane minimum width requirements outlined in the Fire Services Development Design Policy.

The applicant's agent was available to answer Council questions.

6.1 Temporary Use Permit 329 Forbes Road *Maddie Haynes, Planning Assistant*

Bruce Greig, Director of Community Planning, presented this report.

In response to Council questions, Staff clarified that Council approval is needed for mobile vending business licences and the Temporary Use Permit is required because the site is not on Main Street or Peninsula Road where the zoning bylaw currently allows for mobile vending. Staff noted that at a previous meeting, Council supported looking at bylaw and policy changes for mobile vending, but as a lower priority item after housing initiatives.

The applicant, Jason Bival, Owner of Long Beach Event Co. outlined the history of his operation, his planned operating schedule and the need for an on-site commercial kitchen.

Council noted the correspondence included in the agenda package on the proposed Temporary Use Permit, and invited further public input.

Staff read three unpublished correspondence items on the Temporary Use Permit. All three letters were in support of the Permit. There was no additional public input.
